- ✓ Food vendors who are cooking on site must have a fire extinguisher in their booth.

- ✓ Food vendors are responsible for cleaning up their booths at the end of the festival.
- ✓ Food vendors must comply with all Indiana Health Department rules & regulations.

Terms and Conditions for All Organizations & Businesses

Indy Pride, Inc., proudly presents Circle City IN Pride 2009 – a celebration of Gay, Lesbian, Bisexual & Transgender Pride as an educational and entertainment event and reserves all rights as producers. Any reproduction, broadcast or commercial use of any portion of the event, in whole or in part, in any form, without explicit prior consent of Indy Pride, Inc. is strictly prohibited. By submitting a Vendor Application, you hereafter referred to as a “vendor” agree to comply with the following provisions:

- 1) All business or other activity for which VENDOR has rented space must be conducted in the designated booth area ONLY. Distribution, layout or hanging of any items outside designated booth area is not permitted.
- 2) All materials deemed offensive by Indy Pride, Inc. will not be permitted to be sold or displayed. Please keep “adult oriented material” out of view of minors.
- 3) All vendors and employees are expected to monitor themselves on all matters of conduct, attire, etc.
- 4) No displays over 8 ft. in height or extending beyond the 10’ x 10’ booth are permitted without explicit permission.
- 5) Vendor is responsible for paying all fees, and obtaining all permits required by any federal, state or local governmental entity, including, but not limited to, the City of Indianapolis. Please note that Indy Pride is required to submit a list of all participating vendors to the City of Indianapolis. Indy Pride is not responsible for the collection or submission of any such governmental fees.
- 6) Each vendor is required to obtain sufficient and proper insurance. Indy Pride, Inc. assumes no liability for vendors or their invitees or licensees within or around vendor’s allotted area. Indy Pride, Inc. reserves the right to require proof of insurance prior to, during, or following the event. Indy Pride, Inc. reserves the right to remove any vendor not properly insured without any refund or any fees due or paid Indy Pride, Inc.
- 7) Vendors shall not display, offer for review, or sell any illegal or contraband items. The laws of the State of Indiana and local ordinances of the City of Indianapolis shall control. Vendors shall not display, offer for review, or sell any items that are unlicensed and/or copies/interpretations of licensed or registered items at any or all sites and operations of Circle City IN Pride 2009.
- 8) Vendor(s) agrees that it shall indemnify, defend and hold harmless Indy Pride, Inc., its officers, directors, agents, successors and assigns from and against any and all losses, costs, claims, damages and expenses (including attorney's fees) arising from or related to Vendor(s) actions, business activity, booth rental, advertising or otherwise arising from or related to Vendor's participation in the subject event. Vendor(s) agree that it shall further hold harmless Indy Pride, Inc., its officers, directors, agents, successors and assigns from any and all losses, direct or consequential, arising from or related to cancellation, postponement, delay or rescheduling of the subject event, regardless of cause.
